BEING A BYLAW TO AMEND BYLAW 5/2008, SCHEDULE "A", WHICH IS AN AMENDMENT TO THE WATER RATES BYLAW NO. 31/2006 OF THE TOWN OF MORINVILLE.

Pursuant to the Municipal Government Act, 2000 RSA and amendments, thereto, the Council of the Town of Morinville in the Province of Alberta, duly assembled enacts as follows:

1.0 That Schedule "A" be changed to read as follows:

Where it reads: "WATER CUSTOMER ACCOUNT CHARGE - \$22.49 PER INVOICE"

That it be changed to read:

"WATER CUSTOMER ACCOUNT CHARGE - \$4.88 PER INVOICE"



3.0 That this Bylaw take effect March 1<sup>st</sup>, 2008.
